If no embryos are re-frozen at the end of the procedure, a refund for the freezing that did not take place will be provided (£350).

Third Cycle Discounts

At King's Fertility, we value the trust our patients place in us. As a gesture, we offer a 25% discount on every third cycle of the same treatment type (IVF, IUI, or Egg freezing cycle) completed within a twelve month period.*

There's no need to commit to a multi-cycle package upfront – we'll automatically apply the discount when you book the third cycle, so you can plan treatment at your own pace.

This discount applies exclusively and only to the clinic's core IVF, IUI, or Egg freezing 1-cycle fee in effect at the time of treatment and does not include medication, storage, or additional procedures such as ICSI or PGT.

It is applied at the discretion of King's Fertility, in consultation with your clinical team and in line with your individual treatment plan.

*This discount offered relates to self-funded cycles purchased. No other cycle types will be included/counted.

Medication Charges

Medication charges are charged per cycle, please see the approximate medication costs per cycle in the 'Example medication cost' section. This will also be included in your costed treatment plan.

Additional Charges

Additional charges per cycle may include blood tests and swab tests (if not part of routine cycle monitoring), freezing and storage of surplus embryos, medication, and ICSI. Please refer to the individual price list for details. An invoice will be issued before treatment begins and must be paid in advance or upon receipt. Please liaise with the administration team for further information.

These are the Terms and Conditions on which we provide all Services to you. By requesting any of the Services, you agree to be bound by these Terms and Conditions.

INTERPRETATION

The definitions and rules of interpretation in this condition apply in these terms and conditions (Conditions).

Contract: The Patient's request for the provision of Services/Treatment from King's Fertility Limited, and our agreement to provide the Patient with such.

Patient: The person(s) receiving goods and/or services from King's Fertility Limited.

In all matters between the Parties, King's Fertility Limited will comply at all times with the requirements of the Data Protection Act 1998, the Human Fertilisation and Embryology Act 1990, and the HFEA Code of Practice with regard to maintaining the proper standards of medical confidentiality and the handling of personal information of patients.

FEES AND PAYMENT

The Patient shall pay the fees relevant to the Services and Treatment received as set out in the Price Guide. The total price of which will be agreed between the parties.

In relation to consultation appointments, the Patient shall pay all invoices submitted to them in full and cleared funds, upon booking. We reserve the right to cancel any appointment if payment has not been received in full and cleared funds.

In relation to blood tests not included in Treatment Packages, the Patient shall pay all invoices at the time the test is performed.

In relation to medication, the Patient shall pay all invoices, including delivery charges, at the time the prescription is issued. Medications are not returnable or refundable.

In relation to Treatment Cycles, the Patient shall pay all invoices prior to the Treatment commencing (Day 1). We reserve the right to cancel or suspend any Treatment if payment has not been received in full and cleared funds at this time.

King's Fertility Limited reserves the right to amend the prices published in the Price Guide. We will honour any prices in effect at the time the Financial Consent form is signed.

No refunds are due to the patient if Services have been performed.

Refunds to the Patient, per the values in the Price Guide in effect at the time said Treatment was paid for, in respect of Treatment Packages cancelled for medical reasons will be issued within 28 days.

COMMENCEMENT, DURATION AND TERMINATION

Treatment will commence upon meeting certain conditions:

- i. All relevant screening checks of the Patient have been conducted.
- ii. The results have been received by King's Fertility Limited.
- iii. The Patient does not have a pre-existing medical condition or other factor that would exclude them from meeting criteria for treatment.
- iv. The relevant consent forms have been signed.
- v. Cleared funds have been received by us, or funding has been confirmed for NHS Patients

The Contract continues for the duration it takes to provide the Services.

Either party may terminate the Contract without liability to the other immediately on giving notice, and without prejudice to any other rights or remedies which the parties may have, if:

- i. The other party commits a breach of any of the terms of the Contract and fails to remedy the breach (where such a breach is remediable) within 30 days of that party being notified in writing of the breach: or
- ii. The other party is subject to any step towards bankruptcy or liquidation; or
- iii. The other party suspends or ceases, or threatens, to carry on all or a substantial part of its business; or
- iv. The other party fails to pay any amount due under the Contract on the date such payment is due.

Upon termination of the Contract, the Patient shall immediately pay any outstanding amounts on their account.

THIRD PARTIES

From time to time, some additional services may be required in the course of your treatment. Where those Services provided by Third Parties are not included within our standard rates, they will be charged at the Third-Party provider's rates.

CIRCUMSTANCES BEYOND THE CONTROL OF EITHER PARTY

In the event of any failure by a party because of something beyond its reasonable control, the party will advise the other party as soon as reasonably practicable.

King's Fertility Limited shall have no liability to the Patient under the contract if it is prevented from or delayed in performing its' obligations under the Contract or from carrying on its business by acts, events, omissions, or accidents beyond its reasonable control.

LIABILITY

King's Fertility Limited does not exclude liability for:

- i. Any fraudulent act or omission
- ii. Death or personal injury caused by negligence or breach of our other legal obligations.

King's Fertility Limited are not liable for loss which was not reasonably foreseeable to both parties at the time when the Contract was made.

Subject to this, we hereby set out the entire financial liability of King's Fertility Limited (including any liability for the acts or omissions of its employees, agents, consultants, and subcontractors) to the Patient in respect of:

- i. Any breach of the Contract.
- ii. Any use made by the Patient of the Services; and
- iii. Any representation, statement or tortious act or omission (including negligence) arising under or in connection with the Contract.

All warranties, conditions and other terms implied by statute or common law are, to the fullest extent permitted by law, excluded from the Contract.

Subject to the conditions in this clause, King's Fertility Limited's total liability in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise arising in connection with the performance, or contemplated performance, of the Contract shall be limited to the price paid for the Services

GOVERNING LAW, JURISDICTION, & COMPLAINTS

The Contract (including any non-contractual matters) is governed by the law of England and Wales

We try to avoid any dispute, but if a dispute should arise the Patient should contact us in writing to find a solution.

11 Financial Consent

1. I/We agree to be bound by these Terms and Conditions.
2. I/We have seen the current price guide and have discussed the treatment fees for this treatment cycle. I/We agree to pay these Charges in accordance with these Terms and Conditions.
3. I/We understand that these Terms and Conditions and the Price Guide are current at this time, however, the clinic may review and revise Charges and these Terms and Conditions without notice.
4. I/We understand that all Charges must be paid in advance of the appointment, and that failure to do so may result in Services being cancelled, and a cancellation/administration fee being charged.
5. I/We understand and agree to pay all Charges prior to starting the medication, and if Services are cancelled a cancellation fee is charged. I/We understand that the clinic does not offer the option of paying in instalments.
6. I/We understand that all outstanding Charges must be cleared before Services can commence.
7. I/We understand that any charges/arrears apparent must be paid in a timely fashion. Failure to do so may result in the debt being referred to a collection agency. In these cases, I/we may be charged for any legal or other costs that the clinic may incur in recovering the debt, including a fee for reasonable administrative costs.
8. I/We understand the individualised treatment cost plan includes an approximate cost for medication which must be paid for separately.
9. I/We understand that the team at the clinic will order the appropriate Goods for our treatment in accordance with our treatment plan, however, as dosages may be adjusted during the cycle, I/we may need to purchase more Goods or may have some left over.
10. I/We agree to pay for the additional Goods.

11. I/We understand that the pharmacy will Charge a dispensing, management, and delivery fee for their Services.
12. I/We accept that some high-cost drugs may remain unused, and which cannot be returned for a refund.
13. I/We have an understanding of the pricing structure at the clinic and are aware that in addition to the service costs, I/we will be required to pay for any additional Goods and/or Services required for our treatment. We are aware of the different charges, as set out in the Price Guide and agree to pay for these.
14. I/We understand that if a Service takes place (either an egg collection or insemination), that full charges for that treatment cycle are applicable (i.e. IVF/ICSI/FET/IUI etc.), irrespective of outcome.
15. I/We understand that our treatment may require additional Services (such as blood tests, ICSI, HyCoSy, etc.) which are charged separately and are in addition to the procedure costs.
16. I/We understand that additional Services or Goods may be required during the course of treatment, and acknowledge that I/We are responsible for the associated costs. I/We agree to pay for any such additional Services or Goods on the day they are provided (e.g. procedures or blood tests). If payment is not made on the day, King's Fertility will update the patient account accordingly, and an invoice will be issued for the outstanding amount, which I/We agree to pay in full.
17. I/We understand that there is a charge for freezing and storing gametes and embryos and agree to pay this when/if I/we request to have our gametes and embryos frozen. I/We understand the Price Guide for storage and are aware that we will need to pay additional charges, prevalent at the time, for continued storage, after the initial period. Failure to pay Charges may result in the cancellation of the storage facility and loss of any stored gametes and embryos. I/We understand that it is our obligation to provide the clinic with up-to-date contact details for correspondence.
18. I/We understand that our treatment cost covers one follow-up consultation (should the treatment cycle be unsuccessful). The appointment must be within 3 months of treatment, after which time a fee for a follow-up consultation will be charged at the rates current at the time.
19. I/We understand that should our treatment be cancelled (for example due to the Coronavirus (COVID-19) pandemic), I/we will be responsible for any financial implications directly associated with the cycle. This includes medication, blood tests, treatment already undertaken. The finance team will advise of the costs, and these will be payable prior to starting any future cycles.
20. I/we understand if I/we purchase an IVF cycle and the egg collection is performed but there is no transfer performed as no embryos are not created, I/we understand that I/we may be entitled to a £150 refund.
21. I/We understand if I/we purchase a FET cycle and the embryo does not thaw and no transfer takes place, I/We understand that a £150 refund may be due.
22. I/We understand that if I/We opt not to have a fresh transfer (as part of our IVF cycle), I/We understand I/We will not be entitled to the £150 refund for not having a transfer. This applies to patients creating embryos who choose to have a transfer later.
23. I/We understand that one therapeutic counselling session is included in an IVF/FET/Egg freezing cycle(s). All other counselling sessions are chargeable.
